1. The applicant signing the rental agreement must be at least 18 years of age.
2. The facility must be left in the same manner as found. Applicant/Group reserving any activity space will be held responsible for any additional expenses for excessive cleaning and/or damages that exceed the amount of the deposit.
3. A rental fee plus a deposit must be submitted at the time the reservation is made. The deposit will be returned if no damage resulted from the use of the facility.
4. Rooms will not be reserved for any day that falls on a holiday
5. The room rental time frame will be the same time as the pool rental.
6. Any food besides cake and ice cream is not permitted, other than pizza ordered from the Hearth restaurant. No other outside food is allowed.
7. Decorating & Entertainment – Centerpieces, flowers, balloons, and special table covering are welcome for decorating your event. Nailing, tacking, and taping ANYTHING to our walls is not allowed. Confetti, paints, or magic markers are NOT to be used in the facility.
8. The tables and chairs in the facility are what is available for use. The tables and chairs available would equal enough seating for 24 people. If more tables or chairs are needed, they must be requested in advance for use to accommodate the request.

I promise and agree to hold this P.O.A. or any Sugar Springs agents free and harmless from any and all liability damages or claims of any nature whatsoever, including attorney’s fee that may arise from or through my possession. I acknowledge this rental is just for the sole purpose of tables and chairs for a pool party function, and that the space must be left in the manner in which it was found.
